A similar outbuilding has been previously approved under application 2016/4181/P. The main changes proposed are in relation to the roof height proposed to be at the same level throughout the building, with extended green roof.

The main issue I identified with this proposal was the extent of the hardstanding, increased from the previous permission. I requested the applicant to reduce the extended area of sunken hardstanding as per previous permission.
