Proposed Work:

FRONT GARDEN: 1 x Hawthorn (T1) - Thin by 15% and raise over the pavement by 1 - 2m.

1 x Beech (T2) - Thin out the canopy by about 15% and raise low hanging branches over the road by about 2m.

1 x Large Lime (T3) - Thin out the canopy by about 15% and reduce overlong branches by about 2 - 3m. Remove the first 2 small branches as they are too low and obstructing the road signs.

SIDE GARDEN: 1 x Sycamore (T4) - Reduce the height by about 2m.

REAR GARDEN: 1 x Lime (T5) - Thin out the canopy by about 15% and raise any low hanging branches by up to 2m..

- 1 x Lime (T6) Thin out the canopy by about 15% and raise any low hanging branches by up to 2m.
- 1 x Lime (T7) Thin out the canopy by about 15% and raise any low hanging branches by up to 2m.

The Council has considered your notification of intended works to trees dated 03 August 2020 and does not wish to object.
