
- a) Manufacutrer specification details of the proposed boiler flue;
- b) Details of the proposed railings including plan, elevation and section drawings at a scale of 1:10;
- c) Details of all new internal lighting fixtures;
- d) Brickwork details for the raised opening to the fireplace showing new brick head detail.

The relevant part of the works shall be carried out in accordance with the details thus approved and all approved samples shall be retained on site during the course of the works.

Condition 4a): Manufacturer's specification details of the proposed boiler flue;

Please see below specification of the proposed horizontal boiler flue. The colour will be black. As per consen the horizontal pipe will be located on the rear elevation replacing the existing flue pipe outlet for the tank. The data sheet is also submitted as a separate attachment named "Vaillant horizontal flue kit" as part of this application.

Condition 4b): Details of the proposed railings including plan, elevation and section drawings at a scale of 1:10;

Second floor roof terrace:


It is the client's intention to install a brick balustrade in lieu of the approved metal railing at the second floor roof terrace. The brick balustrade would be an identical replica of the existing balustrade at the adjoining neighbouring property no. 9.

Please see below reference photograph showing the detail of the existing neighbouring property. Please note that we have previously tried to obtain your informal view on this change from metal balustrade to brick balustrade but haven't received any feedback from you to our emails and phonecalls yet.



Condition 4c): Details of all new internal lighting fixtures;

LED downlights are proposed to be installed as per approved Schedule of Works, item 4a "ceiling spotlights in the basement, bathroom, rear hall to bathroom and second floor room." These are the areas where modern timber boarded ceilings are being replaced.




The proposed downlights are Evofire Fire Rated Downlight 70mm cut-out. Please refer to separate product data sheet named "LED Downlight spec sheet Product-806481" as submitted as part of this application.

In other rooms the existing ceiling pendant outlet will be utilised and the pendant will be replaced with a standard pendant light.

Condition 4d): Brickwork details for the raised opening to the fireplace showing new brick head detail.

Please refer to brickwork elevation drawing "20031_PA-04 – Proposed chimney breast elevation" as well as details provided by the structural engineer, submitted as separate documents as part of this application, titled "18107 Chimney Breast Elevation & Section".

The raised lintel will be formed as brick soldier course to match the existing detail at the raised level.
