e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

We would like to fell the Weeping Ash tree which has a hollow stem, with cavity open to the west from 1.6-2.1m. The convoluted branch structure of the tree makes the tree top heavy with the potential to snap out in high winds, making it dangerous due to its close proximity to the house. An extension is also being added to the back of the house. About 2-3 metres away from the Ash tree is a Japanese Maple tree which is about 7.5 metres tall. It is an attractive species with a high canopy. Removing the Ash tree will also allow the Maple to have more space and its splendour to be seen more widely.

The reasons for felling the tree is for safety purposes due to the cavity. It will also allow more light in to the property and garden. Leaving the Maple tree will make the garden more aesthetically pleasing.

I have attached photos of the tree to show the cavity, its proximity to the house and the Japanese Maple tree which is growing close to the Ash.
