Licensing Act 2003

Re: Linh Ta Duy, 2 Canfield Gardens, London NW6 3BS

Please find enclosed the Personal Licence Badge for the above mentioned person.

The personal licence is made up of two parts. The first part is the licence and this should be kept in a safe place for future reference. The second part is in the form of a plastic card with a photograph. The applicant must produce this card on request to a Police Officer or an Authorised Officer of a Licensing Authority. Failure to do so is an offence for which they will be liable on conviction to a fine of up to £500.

A personal licence ceases to have effect when;

- I. it is revoked or forfeited**
- II. during any period when it is suspended or**
- III. when it is surrendered.**

A personal licence holder may only hold one personal licence at any one time. A personal licence is valid **throughout England & Wales** regardless of where it has been issued.

As a holder of a personal licence, they are required to comply with the statutory requirements contained in the Licensing Act 2003. Failure to comply with these is an offence for which they will be liable on conviction to a maximum fine of £500. These requirements are listed below.

They have a duty to notify this Licensing Authority if they change their name or address.

If they are charged with a relevant offence whilst holding a personal licence, they

must no later than the time they make their first appearance in a magistrate's court produce to the court the personal licence or notify the court that they hold a personal licence.

If they are convicted of a relevant offence or a foreign offence they must notify this Licensing Authority giving full details of the conviction, and return their personal licence when giving the notification. If they cannot return their licence, they must provide a statement of the reasons why it cannot be returned.

Details of what are relevant and / or foreign offences can be found in the Licensing Act 2003. This information is also contained in the Applicant Guidance Notes issued by this Licensing Authority.

If their personal licence is lost, stolen, damaged or destroyed, they may apply to have a copy issued for which a fee will be charged.

They may surrender their personal licence at any time during the life of the licence. To do so they must give notice to this authority and return the licence with the notification. If they cannot return their licence they must provide a statement of the reasons why it cannot be returned.
