e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1Cherry Plum(*Prunus myrobalan*) 10-11m in height. The tree is multi-stemmed, its main unions are compression forks with included bark. To re-reduce the tree canopy area by 1.5m in height and 2m from the lateral re-growth, creating a well-balanced natural appearing crown shape (This is all handsaw and secateur work). Clean out the crown and remove all deadwood. Maintaining this tree by of means a re-reduction every 36 months will aid in reducing the mechanical loading on these forks.
