-There are cavities at the base, perform resistograph test with recommendations.

T18 - Large Sycamore

-There are cavities at the base, perform resistograph test with recommendations.

T19 - Large Sycamore

-Remove deadwood, crown lift to 5m and carry out an aerial inspection.
