e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore x 2 (T1, T2) – Prune back to boundary line.
Ash, hawthorn, leylandii (G3)– prune hedge back to boundary line along property boundary.
Copper beach (T4)– Prune back to previous cuts on sections overhanging garden of 5 Telegraph Hill, (2-2.5m reduction).
The reason for all the works is to let more light into the property, restrict root growth, and limit branch/leaf drop over 5 Telegraph Hill.
