Trimming Pine and Silver Birch trees, reducing crown by 1/3 of both with professional tree surgeon. Exact same process was conducted previously, and it is time for another trim. Trees are in great health, and hence we intend to use a professional tree surgeon in order to ensure this continues to be case.
