An inspection of the trunk of the tree was carried out and after tapping the tree with a mallet it was discovered to be hollow

Sycamore - Crown reduce the height and spread by 33% (3-4m)
Thin throughout the crown by 10%
This tree is growing very close to the large north boundary wall

Maintenance works in line with good Arboricultural practice
