The proposed development is not considered to result in harm to the character and appearance of the original property or surrounding conservation area. Whilst it is acknowledged that metal railings are not a common feature of properties in the immediate vicinity there are other similar examples along Oakhill Avenue and as such they are considered appropriate in this context.

The proposed works are not considered to have a harmful impact on the amenity of any adjoining occupiers.

No objections were received following statutory consultation. The sites planning history has been taken into account when coming to this decision.
