## Proposal:

IN GROUNDS: 2 x Common Lime (Tilia X europaea) (T1 & T2) - Remove weak, suppressed or diseased branches, prune back from buildings to provide 3m clearance, remove stem sucker growth and ensure clearance over footpath by 3m and over road by 5m. Clean out canopies of stem suckers.

- 1 x Common Lime (Tilia X europaea) (T3) Carry out GMS.
- 1 x Common Lime (Tilia X europaea) (T4) Carry out GMS.
- 1 x Common Lime (Tilia X europaea) (T5) -Thin canopy density by approx. 20%.
- 3 x Sycamores (Acer psuedoplatanus) (T7, T8 & T9) Reduce north lateral spread by approx. 3m to reduce weight on lateral branches growing over road.
- 1 x Common Lime (Tilia X europaea) (T10) Reduce x 1 overlong lateral limb growing over road to canopy line.
