- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Thin crown to remove approximately 10% of live branches to improve light and air penetration through crown. Most thinning cuts will be between 1 and 2 centimetres in diameter.
- Reduce crown height and spread by approximately 2-3 metres to provide clearance to house

Prune TG2 Various, Cherry, Conifer, Ash group located at the back of property according to the following specifications:

- Reduce back to boundary wall line

Prune T3 Bay located at the front of house according to the following specifications:

- Reduce crown height and spread by approximately 1-2 metres to provide clearance to building
