e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

It is proposed to remove the epicormic growth from the base and main stems of three Lime trees (G1 on sketch plan). It is also proposed to cut back the overhanging lateral branches of the neighbouring Lime T1 (which is managed by pollarding - see supporting photo).

As per section 17/2/d of the Town and Country Planning (Tree Preservation) (England) Regulations 2012, it is requested that a condition is added to allow these minor works to be repeated on an annual basis.
