The cohort will change from its original occupants who were sheltered housing residents to small homeless families. There will be no renovations externally that will change the appearance of the building. Refurbishment works will include repointing and repairs. Internally we plan to retain the existing layout of 24 units and upgrade kitchens, bathrooms and any works to comply with building regulations and fire safety to make it habitable and to standard for use as temporary accommodation.
