1 x Sycamore Group (T16) - Fell to ground level.
13 x Holly (T20, 30, 53, 61, 65, 84, 93, 100, 102, 105, 111, 112 & 114) - Coppice.
3 x Ash (T21, 50 & 85) - Fell to ground level.
2 x False Acacia (T86 & T96) - Fell to ground level.
2 x Horse Chestnut (T91 & T92) - Fell to ground level.
3 x Yew (T95, 97, 99) - Fell to ground level.
1 x Holly (T98) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 11 September 2020 and does not wish to object.
