e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Robinia tree (R1) – application to fell. The tree grows very close to the garden boundary to no. 11 Grove Terrace. If allowed to grow any bigger, it will undoubtedly cause damage to, or topple, the 18th garden wall between nos. 12 and 11. Since it is part of a densely wooded area, felling this Robinia will allow adjacent trees to flourish all the more. There is a much smaller self-seeded sapling from this same tree (R2) growing on the edge of the wooded area adjacent to the lawn. We are applying to fell this tree too. See sketch attached.
