Front garden  
T1-Evergreen(Holm)Oak(Quercus ilex)-2x large stems from same bole  
-treat as single crown, reduce by 25%(1.75m)to suitable growth points with emphasis on reducing shading over small lawn from overhanging branches in SMALLER stem  
-thin crown by 10% to allow more light through canopy  
-remove any deadwood or crossing branches

Rear garden  
T2-Sycamore(Acer pseudoplatanus)  
-pollard by reducing ALL stems by 50%(4m) to suitable unions

T3-Evergreen Magnolia(M.grandiflora)  
-light reduction shortening branch lengths by up to 1m from tips to suitable growth points
