Prune T1 Mulberry located at the back of property according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Raise lower branches to a height of 3-4 metres to improve clearance over garden.
- Thin crown to remove approximately 10% of live branches to improve light and air penetration through crown. Most thinning cuts will be between 1 and 3 centimetres in diameter.
- Reduce crown height and spread by approximately 2-2.5 metres to enhance natural form.

Prune T2 Maple located at the back of property according to the following specifications:

- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Raise lower branches to a height of 2.9-3 metres to improve clearance over play area.
- Reduce crown height and spread by approximately 1-2 metres to enhance natural form.

Prune T3 Fig located at the Neighbouring Garden according to the following specifications:

- Reduce back to boundary fence line

Prune TG4 Hazel, laurel located at the left side of property neighbours side according to the following specifications:

- Reduce back all overhanging branches into garden to boundary fence line.
