Summary.....6no' Sycamore trees.... 4 located to front of Synagogue.... 2 located to the rear of the Synagogue.

2 trees at front require felling due to structural and biological problems. It is not practical to replant in same position due to site confines by way of access ramp. 4 require remedial pruning to alleviate encroachment to buildings, low branches over footpaths and low branches over road. Removal of dead wood from crown in all trees.
