T1 & T2 - 2 x London Planes: Repollard. Prune back to most recent pollard points.

T3: Acer - (left hand boundary): Reduce lateral and sub-lateral growth by up to 1.00m. Reduce crown height by 0.50-1.00m. Thin crown density throughout by 20%.

Reasons: General maintenance to manage the trees dimensions and help increase light levels.
