Crown reduce height by branch lengths of up to 4m - 4.5m Crown reduce spread by branch lengths of up to 3m - 3.5m to give even and flowing canopy outline by retaining soft furnishing growth
Remove all epicormic growth to 5m height Remove any remaining major deadwood

T3Hawthorn
Fell to ground level
Provide replacement planting: 1 x Pyrus calleryana 'Chanticleer' (14-16cm girth heavy standard)

T4
Purple plum
Fell to ground level
Provide replacement planting: 1 x Pyrus calleryana 'Chanticleer' (14-16cm girth heavy standard)

T5
Himalayan birch
Fell to ground level
Provide replacement planting: 1 x Amelanchier arboreal 'Robin Hill' (14-16cm girth heavy standard)

T6Cherry
Fell to ground level
Provide replacement planting at rear of property: 1 x Pyrus calleryana 'Chanticleer' (14-16cm girth heavy standard)
