Rear garden of 8 Gayton Crescent
T1 Sycamore x 1 (Acer pseudoplatanus)
- A collection of residents from 37-43 Rudall Crescent want the sycamore in the garden of 8 Gayton Crescent heavily reduced.
- The tree has previously been badly reduced at around 14m only. The wounds that were left have allowed decay to get into the limbs that were cut and this has caused two snap outs that have landed in the gardens and on the fences of residents on Rudall Crescent.
- The roots of the sycamore have spread as far as 43 Rudall Crescent and are causing cracks in the wall in their garden.
Suggested work:
- Heavily reduce all round by 3-6m to round the top of the canopy off with the previously reduced lower limbs.
- This will require extensive rigging and a drop zone within the garden of 8 Gayton Crescent.
We consider these works to be necessary and urgent.
