T1, Unidentified Shrub. T2 and T3 - Lawsons Cypress. Request to remove these trees. Excessive shade and water demand makes growing of other plants difficult. Shade in ground and first floor windows. Client wishes to re-landscape front garden incorporating the extension of lawned area, growing smaller plants and wild flowers. A more attractive broadleaf species is desired in place of where T3 currently stands.
