Details of the pre-application advice received

The proposed extension is modest measuring 2.6m deep, 6.4 wide and 2.7m high. It would be brick to match the existing building with full height aluminium fenestration on the rear elevation.  
The scale of the proposed extension is subordinate and respects the prevailing pattern of development of the terrace. It is noted that No.91 and 85 have similar sized extensions. The use of brick to match the existing is welcomed and, given its low siting and location to the rear, the use of aluminium would be acceptable and help differentiate it as a modern addition. Full height fenestration is a characteristic of the terrace and would be supported.  
It is considered that the proposal would preserve the character and appearance of the host property, terrace and Highgate conservation area.  
Conclusion  
The proposed extension would be acceptable in principle subject to further tree information.
