T1 Common Crab Apple x 1
- all round reduction removing 2m off the top; 1-2m off the sides; and thin the overall canopy by 20%, whilst re-shaping the overall crown.
rear garden
T2 Acer spp x 1 - Tree on cricket pitch, cut back by around 2m on the two lowest laterals by the patio area only.
rear garden
T3 Cherry x 1 (Prunus spp) The union at the base of the tree is in poor condition and around 40% of the canopy has died due to an apparent fungal infection. In addition, the location is poor as it is competing for light with two adjacent trees.
Suggested work:
- fell to ground level.
rear garden
T3 Cherry x 1 (Prunus spp) Grind down stump to approx. 300mm below ground level.
rear garden
T4 apple x 1 This paradise apple needs reshaping,
suggested work:
- reduce the top by 1-2m, the sides by 0.5-1m, crown lift and reshape.
- prune the epicormic growth at the base of the tree to create a bush.
rear garden
T5 Cherry Plum x 1 (Prunus myrobalan) remove the epicormic growth from the crown break, predominantly on the house side away from guttering.
