Proposed Work:

FRONT GARDEN: 1 x Poplar (A) - Reduce height and spread by 3 - 4m

REAR GARDEN: 1 x Ash (C) - Lift crown by 5m and thin out branches including removal of two limbs with a diameter of 10cm and approx. 3 - 4cm om girth branches, thin crossing branches and any side leaders by up to 1/5 of a branch removed and crown thin of 20%

1 x Laurel (C1) - Reduce height and spread by 1.5m.

1 x Bay - Reduce height by 50%

1 x Laurel (B) - Fell to ground level and grind stump.

1 x Medium Laurel - Trim round on the right about 20cm off branch girth 0.5 - 2 cm.

The Council has considered your notification of intended works to trees dated 01 September 2020 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
