## **Householder Application Granted**

Proposal: Erection of a single storey ground floor side/rear infill extension. Drawing Nos: Proposed Floor Plans 2000 Rev A, Proposed Elevations and Section AA

3000 Rev A; site location plan; Design and Access Statement by Carter Designs.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

3 The development hereby permitted shall be carried out in accordance with the following approved plans- Proposed Floor Plans 2000 Rev A, Proposed Elevations and Section AA 3000 Rev A; site location plan; Design and Access Statement by Carter Designs.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 2 Reasons for granting permission.

The proposed single storey side infill extension will match the size, height and design of the recently allowed extension at no. 30 next door (planning permission ref 2020/1365/P dated 10/06/2020). The extension is considered subordinate to the host building in terms of its form, scale and location. It would not project beyond the existing depth of the rear closet wing nor the adjoining permitted extension. The materials of matching brickwork and large glazed roof are considered appropriate in this location. The proposal would thus not detract from the character or appearance of the building or the surrounding area.

Due to the extension abutting the adjoining neighbour's permitted extension and not projecting beyond existing rear wings, there would be no harm to the amenity of adjoining residential occupiers. The proposed rooflight would not cause harm in terms of light spillage.

No objections were received prior to making this decision. The application site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1 and D1 of the London Borough of Camden Local Plan 2017 and policy 2 of the Fortune Green and West Hampstead Neighbourhood Plan 2015. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework 2019.

3 This approval does not authorise the use of the public highway. Any requirement to use the public highway, such as for hoardings, temporary road closures and suspension of parking bays, will be subject to approval of relevant licence from the Council's Streetworks Authorisations & Compliance Team London Borough of Camden 5 Pancras Square c/o Town Hall, Judd Street

London WC1H 9JE (Tel. No 020 7974 4444). Licences and authorisations need to be sought in advance of proposed works. Where development is subject to a Construction Management Plan (through a requirement in a S106 agreement), no licence or authorisation will be granted until the Construction Management Plan is approved by the Council.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
