Mature Oak: Approximately 16.00m. Reduce back to previous most recent reduction points, approximately 1.50-2.00m whilst preserving a suitable amount of furnishing growth. Remove Ivy from main crown structure down to main crown break and reduce remaining Ivy mass as hard back as is practicable. Reason: General maintenance.
