Purple Plum (T4) - Fell because of multiple Ganoderma fruiting bodies present at base, poor vigour, lean toward road and high risk target area. Hornbeam (T6) - Fell because of of presence of Meripilus giganteus at base with extensive lean towards very high risk target area.
