The residents and the gardener all testify to the lean on this tree increasing over the road- implying root plate instability/weakness. The physiological form of the tree backs this up as you'd expect the branches at the top of the tree to be growing straight if this was purely an historic lean whereas here all branches appear to be leaning.
