T2Japanese Maple x 1 (Acer japonicum) This tree has outgrown its location blocking light from gardens.

Suggested works:

- Selectively prune all round by approx. 1m to shape and contain

Front garden

T3Amerlanchier 'Robin Hill' x 1 Suggested works:

- Reduce all round by 1m all round- Clean out crown
