Mature Sycamore: Approximately 9.00-11.00m. Reduce Ivy back to main crown break, (retain ivy mass on main stem). Reduce lateral and sub-lateral branches by 20% (approximately 0.50-1.00m). Reduce crown height by 0.50m where practicable. Thin crown density by 15%. Remove dead wood.

Reason: General maintenance and to control encroachment of the Ivy.
