 - c Not vary any work shown on the drawings without obtaining prior approval from the Architect.
 - d Be responsible for requesting from the Architect any additional information required.
 - e Supply to the Architect all shop drawings, illustrations, specifications, etc. of all specialist work to be incorporated in the Main Contract Works.
 - f Immediately inform the Architect if any work shown on this drawing is not in accordance with the relevant Codes of Practice, recognised good practice throughout the industry and does not comply with the relevant Local Authority By-laws or Building Regulations.
 - g Immediately advise the Architect/Quantity Surveyor of the effect upon programme and cost of any alterations to the proposed works shown on this drawing.

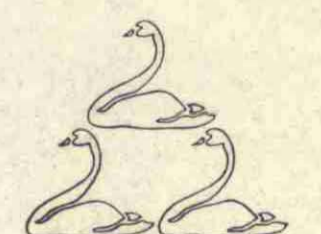
