e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Contorted willow (T1) – Reduce by up to 2m, back to previous cuts.

Pear (T2) – Reduce by 2m in height.

Apple (T3) - Reduce by 1.5m on all aspects.

Hazel (T4) - Re-coppice or reduce to 3m in height.

All the works are to allow more light into the gardens and restrict the root growth.
