e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Silver Birch – Left Hand side (LHS) - Planted for the owners by a garden designer 20 years ago. Now out growing its location, Leaning and causing excessive shading of the garden and beds and is in close vicinity with the neighbouring Birch Tree which is a better specimen. . . Fell to ground level

T2 - Silver Birch - Right hand side – Crown reduce the whole tree by approx 2m to form a tighter crown. Crown thin by 20%

T3 - Neighbours Maple (Crimson Queen) (no.17 Greenway gardens) - Reduce approx 6 selected lateral branches of no more than 2" in diameter growing over Claudia's garden by approx 1.5m only. Retain height.

T4 - Neighbours Sycamore (no 15 Greenway Gardens / flats) – Reduce approx 4 lateral overhanging branches of no more than 3" in diameter by approx 2m. Do not reduce height
