## Assessment

The s.211 notice is for the removal of an evergreen Magnolia tree from the front garden of a residential property that is situated within the Hampstead Conservation Area.

This small tree approx. 4m in height is visible from the public realm and is considered to provide amenity to the public to some degree. However, a cherry tree in the same front garden which is close to the boundary with the highway and is far more prominent, largely screening the Magnolia from public view from most angles and is not proposed for removal.

The Magnolia tree was planted in a position that is not sustainable in the medium/long term due to its proximity to a retaining wall and the stairway up to the entrance to the property. The tree would be under continual pruning pressure if it were to be retained and is far from achieving its ultimate size and form. The tree is not next to the pavement, contrary to one objection received.

The tree is not considered to significantly contribute to the character or appearance of the conservation area. The tree is not a noteworthy example of its species and is not of a rare species. The tree is of no known cultural or historical significance.

The Council has no powers to add conditions relating to replacement planting or otherwise when determining s.211 notifications.

The draft extensions CPG is of no relevance to s.211 notifications.

The Council has no powers to prevent the submission of s.211 notifications.

It is not expedient for the Council to serve a tree preservation order to protect the tree. The Council does not object to the proposed works.
