Trees numbered as per enclosed map:

T1 - Poplar - Re-pollard as per previous practice

T2 - Large Cherry Decayed and dying - Fell to ground level and grind stump including large surface roots.

T3 - Poplar – Re-pollard as per previous practice, taking care of the climbing rose within

T4 - Large Poplar in adjacent property - Cut back crown to boundary line. This to be done without gaining access to the adjacent property which is problematic. The work will involve the use of ladders and pole saws.

T5 - Large Magnolia - Lift crown to 1.5m all round, lightly thin and reduce extremities as directed on site.

T6 - Acer Tree - Lightly thin and prune to shape

T7 - Acer Tree - No room to develop - Fell to ground level and grub out stump

T8 - Cherry Tree - Lightly reduce overall by 0.5m

T9 - Amelanchier - Lift crown to 2m all round, lightly thin through and carefully reduce spread over pavement and car park.
