We would like to reduce the plum tree (T1) by about 2 metres and reduce the overlong leader back in to shape to bring light in to the garden and for safety purposes due to playground area.
We would like to re-pollard the 3 Lime trees along the front boundary as they are very overgrown. This would bring more light in to the school and necessary work for safety purposes due to playground area.
