DECISION

Town and Country Planning Act 1990

Certificate of Lawfulness (Proposed) Granted

The Council hereby certifies that the development described in the First Schedule below, on the land specified in the Second Schedule below, would be lawful within the meaning of Section 192 of the Town and Country Planning Act 1990 as amended.

First Schedule: Erection of a rear roof dormer and installation of 2 rooflights to the front roof of the dwellinghouse (Class C3). Drawing Nos: E01 RevB, E02 RevB, E03 RevB, E04 RevB, P01 RevB, P02 RevB, P03 RevB, P04 RevB, L01 RevA, L02 RevA.

Second Schedule: 25 West End Lane London NW6 4NU

Reason for the Decision:

- 1 The rear roof dormer is permitted under Class B of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.
- 2 The rooflights in the front roof slope are permitted under Class C of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

- 3 The development would only constitute permitted development if the materials used in any exterior work to the roof extension, subject to the grant of this certificate, shall be of similar appearance to those used in the construction of the exterior of the existing dwelling house, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015.
- 4 The development, subject to the grant of this certificate, would only constitute permitted development where the edge of the enlargement closest to the eaves of the original roof shall, so far as practicable, be not less than 20 cm from the eaves of the original roof, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015.
- 5 The development, subject to the grant of this certificate, would only constitute permitted development where the roof lights would project no more than 150mm beyond the plane of the roof slope, in accordance with Condition C.1(b) of the Town & Country Planning (General Permitted Development) Order 2015.
- 6 You are advised that, in order to comply with the parameters of permitted development as set down in the Town & Country Planning (General Permitted Development) Order 2015, you must ensure that the works do not include the installation, alteration or replacement of a chimney, flue or soil or vent pipe.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
