The solar PV panels proposed would be mounted flat against the existing south-facing roof pitches and not project further than 200mm from this line (only 150mm). Additionally, no part of any solar panel will be above the existing roof ridge-line. These panels are mounted towards the rear of the side roof-pitch to the property and would not be visible from the street.

Panels should not be installed above the highest part of the roof (excluding the chimney) and should project no more than 200mm from the roof slope or wall surface.
