1 x Purple Plum - A stem has previously broken out of this tree and the tree now has a limited life  
Reduce the height by 2m  
Reduce the spread to balance and shape

1 x Sycamore - Cut the entire tree to ground level

Please see attached decay detection report for Sycamore and Purple Plum. Maintenance works in line with good Arboricultural practice.
