Tree No. 1811 - prune away from structures 2m clearance (touching building)
Tree No. 1812 (Prunus avium) - prune away from structures 2m clearance; crown lift 4m; (to clear building)
Tree No. 1813 (Robinia pseudoacacia) - prune away from structures 2m clearance; crown lift 4m (to clear building)
Tree No. 1816 (Buddleia davidii) - fell and poison
