2.1 x Laburnum – Remove the deadwood. General maintenance.

3.1 x Portuguese Laurel (dead) – Fell to ground level. Shrub is dead.

Rear Garden

4.1 x Macrocarpa which is 70% dead – Fell to ground level. The tree is dead.

5.1 x Green gauge which is dead – Fell to ground level. The tree is dead.
