- 1.1 x Portuguese Laurel Cut back as tight as possible, using the hedge cutter, into a ball shape. General maintenance and reduce overhang.
- 2.1 x Laburnum Remove the deadwood. General maintenance.
- 3.1 x Portuguese Laurel (dead) Fell to ground level. Shrub is dead.

Rear Garden

- 4.1 x Macrocarpa which is 70% dead Fell to ground level. The tree is dead.
- 5.1 x Green gauge which is dead Fell to ground level. The tree is dead.
