Thuja (T2) - fell. This is the tree at the far right of the hedge which runs laterally across the middle of the garden, as viewed from the property
Cherry (T3) - reduce to previous reduction points (2-2.5m reduction, 25%)
Oak (T4) - reduce to previous reduction points (1.5-2m reduction, 25%)
