Reason: This tree is completely dead and needs to be removed before it begins to break up and fall.

T3: Bay: Reduce crown height by approximately 25%. Trim lateral and sub lateral branches by approximately 20% as is practicable.

Reasons: General maintenance unless otherwise stated.
