8. 1 x Sycamore Tree - Thin by 20%, remove the deadwood, reduce back from the building by 2 metres and crown lift by removing the lower suckers. General maintenance and to reduce the overhang to the communal areas, pavement and building.

Rear Garden

6. 1 x Bay close to both properties - Reduce the height by 4 metres, reduce all by 2 metres and shape in as best as possible. Reduce the overhang to the properties.

7. 1 x Mulberry tree - Light reduce of the tips and remove the dead wood. General maintenance and reduce overhang to garden area.
