e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 Black Poplar-

Cavity at base of tree (Fig. 1) which is 300mm in diameter and extends over 1m into the stem and is heavily colonised by Rigidiporus Ulmarius (Fig. 2). This causes a brown rot of the heartwood above and below ground. Due to the species of tree (weak wood and susceptible to decay), it's location (within a tree's length of a very busy road and junction) and the type and extent of the decay I recommend felling this tree down to 8m from ground level leaving it as a monolith

T2 Black Poplar-

The crown of this tree is 90% dead and has large Ganoderma bracket (causes a selective white rot of the tree) at base of tree (Fig.3). Recommend felling this tree to ground level within 3 months.

T3 Dead Stem-

Dead stem leaning on wall. Recommend felling to ground level within 3 months.

T4 Ash-

Remove Ivy to 3m from ground level, then re inspect.

G1 Ash group-

Lift tree crowns to 3m from ground level, prune to clear street furniture by 2m and remove deadwood >30mm.
