T4: Ash: Located in the central parking area. Reduce crown by at least 30%/re-pollard as necessary.

T2: Sycamore: Located on the main access drive. Raise crown by 15-20%. Remove dead wood. Thin crown density by 15-20%.

G1: Group of Sycamore: Located to the left of the access drive at Highgate West Hill. Remove two broke hung limbs.

Reasons: General maintenance.
